TREASURER'S REPORT: In Jason's absence, the Report was read out by C. Nott and included within the Agenda.

I am still waiting on all audits and books (cheque Books, Receipt Books, Deposit Book etc.) to be returned. There are still with Christine Stevens.

The 2015, 2017 and 2018 Audits are still not complete, once these are complete all books & records will be returned to the Q.H.M.C. and I will be able to process all affiliation renewals. Despite numerous requests (Verbal and Written) to Christine, I have not been given the name of the Auditor. I was advised that Christine Stevens may have time on Tuesday 18th September 2018 to complete the treasurer report/s and then give to accountant to audit. I have not been advised if this has been done.

It was also discovered that an Acquittal for a grant of \$5,910.00 from Ipswich City Council paid to Q.H.M.C. on 4 May 2016 has also not been completed. Ipswich City Council has advised that a number of reminders had been sent to Christine Stevens, however, the Acquittal remained uncompleted.

I have now completed the Acquittal without receipts attached and have advised Ipswich City Council that we will provide these once we get them in our hands (still with Christine)

I have also partially completed and paid for 3 years of Annual Returns (2015, 2017 & 2018) with the Office of fair trading which were outstanding. These are now only waiting for the completed audited financial reports to be added at which point the office of fair trading can process these.

C. Nott advised the Meeting that the Committee has looked at finding an Auditor for 2018 - 2019. Chartered Accountant Peter Jorgensen and Associates, 1050 Manly Rd., Tingalpa has been recommended and duly appointed. Jason Dodge and C. Nott have spoken to Peter with an approximate cost of \$450 - \$550 per report.

MEMBERSHIP REPORT:

A large number of Affiliation forms have been received. These will be processed, and all Club contact details updated once all audits have been completed and all books, records etc have been returned to Q.H.M.C. C. Nott explained the process of recording the Affiliation forms for 2019 and that Unfinancial Clubs will be contacted later.

A.H.M.F. Delegates are not in attendance. The A.H.M.F. A.G.M. is being held this week Friday 28th – Saturday 29th September in Adelaide. A Report will be provided at the next Meeting. A total of 16 Delegates will be attending, 2 observers and 4 guest speakers. C. Nott read out the Subject matters the guest speakers specialise in. 2018 Conference and A.G.M. Agenda was available for perusal.

Border Force will be in attendance regarding Asbestos discussion. The President stated that a Commission was set up to investigate all asbestos coming into Australia i.e. in the following: toys/boating/caravans/shipping/many industrial, mining and building. The Commission took great expense and time to reach its findings. When it went to the Senate is was rejected. It would cost the Government too much to police, so no recommendations were implemented. However, Border Force has stopped 60 vehicles of the same type of which 9,000,000 (some manufactured in Australia) that have been driven on Australian roads for some 60 years. So Q.H.M.C. along with similar organisations have proposed a written submission to be presented on behalf of Q.H.M.C. to the Australian Historic Motoring Federation A.G.M. This is ultimately to be presented to the Federal Government. It is regrettable that some internal matters were made public however not in full. The Q.H.M.C. Committee prefers Doug Young to be spokesperson on Asbestos submission and other matters at the A.H.M.F. A.G.M.

Further discussion followed with input from Delegates present.

NATIONAL MOTORING HERITAGE DAY:
