Before the meeting

Jason Dodge on approaching the Meeting area with Trevor Beutel (uninvited guest on his Mobile phone to another person), Jason stated "I have contacted the Police as you are not sitting 1.5 metres apart and I advise you to move to the correct distance." Unbeknown to Jason Dodge, Albert Budworth had advised the Police about the Meeting and was given a reference number.

As President Carle Gregory was waiting for an invited guest to arrive, Jason Dodge slapped down on the table in front of Albert Budworth and Carle Gregory a plastic sleeve containing QCAT Form for "Application for minor civil dispute – minor debt" dated 19 th May 2020 (not 28 th May). Jason stated "You've both now been served individually". (Same as C. Nott received 19 th May 2020 as she was given four copies – Cheryl Nott, Albert Budworth, Carle Gregory and Q.H.M.C.)

Jason Demanded to use the toilet and was advised that the building was decommissioned Queensland Historic Motoring Council Inc. – 1376 Old Cleveland Road, Carindale Qld 4152 due to Health restrictions. Jason demanded that the building be opened to use the Toilet. Albert Budworth co-operated and unlocked the building so Jason could use the toilet then locked the building.

Both returned to the Meeting.

Jason demanded that the Meeting start at 7.35p.m. and Jason tried to run the Meeting.

The President declared the Meeting open at 7.35p.m. welcomed and thanked the ten invited Delegates for their attendance.

Present:

Carle Gregory, Albert Budworth, Cheryl Nott, Jason Dodge, Bill Martin, Doug Murphy, Ernie Taylor, Rod Roberts, Col Hinxman, Val Sharpe. Plus one uninvited Delegate Trevor Beutel. Carle Asked if all present had signed the attendance book and collected the Agenda.

Apologies:

Christine Stevens, Rod Graydon.

The President advised there is to be no recording of the Meeting.

Jason and Trevor continued to record plus Jason video taped.

The President advised there is to be no talking over other Delegates and no interjections. This was followed by Jason Dodge being troublesome by interjecting, video taping and shining a torch in Delegates eyes.

Secretary's Report:

The Minutes of the 27th February 2020 General Meeting were distributed prior to the Meeting. That the Minutes of the General Meeting be accepted as a true and correct record with no corrections.

Moved: Cheryl Nott. Seconded: Ernie Taylor All in favour. Nil against. Carried.

Jason refused to sit on a chair or at the table with other Delegates.

Jason demanded a table. Meeting on hold. Albert Budworth co-operated again and

unlocked the building and obtained a table and relocked the Building and placed the table and

chair 1.5 metres away from the Delegates Table. Jason sat at the table on a chair and shining a bright

light continuously at the Delegates and Committee for the rest of the Meeting until Jason complained of chest pain.

Jason complained about the notice of Meeting not sent to all Clubs. The President replied that other clubs were notified but due to Queensland Government Health restrictions only ten delegates were invited.

To discuss Jason Dodge: behaviour, problems and Positions within Q.H.M.C.

Jason complained about the Website being Hacked blaming Carle Gregory. Carle Gregory knew nothing about it.

Jason also complained about Carle Gregory contacting Crazy Domain.

Carle replied that he had been blocked out of the website.

Jason stated : "Why did you not contact me?" Carle replied that Jason had been advised. Jason became agitated and aggressive. Jason asked a question and when Cheryl replied Jason would state "Apology please" This happened four times.

Jason interjecting and talking over people and became more agitated, talked over people, demanding and dictating telling The President how to run the meeting.

At 7.43p.m. President called for suspension of Standing Orders.

Val Sharpe **motion:** "Under circumstances with Health restrictions and internal problems that the Meeting be suspended until the situation is over then problems have to be solved. Keep things simple." Val Sharpe stated that Q.H.M.C. is an organisation of Clubs, over time Q.H.M.C. Has started organising events like National Motoring Heritage Day. Delegates Have their own Clubs to do this. This is a Council of Clubs. Problem has to be Solved.

Jason shining bright torch light in Delegates eyes since 7.45p.m.

Jason demanded a drink of water and interjected repeatedly whilst Val Sharpe had the floor.

Val Sharpe went to speak to Jason, when Jason lost control of and dropped or flipped his mobile phone on the cement floor.

Jason complained he had been assaulted. Jason became more disrupted and aggressive

8.07p.m. Albert Budworth contacted Police.

Rod Roberts motion: That Jason Dodge be removed from all Q.H.M.C. positions he holds in the Council, provided that the Constitution is followed and evidence provided.

Seconded: Albert Budworth.

Jason Dodge demanded an ambulance - "I've got chest pain".

Both Jason and Trevor Beutel refused to call the ambulance,

Albert Budworth co-operated and dialled 000. Albert relaying messages

Doug Murphy went to the front gate of premise for arrival of ambulance.

Jason Dodge complained of chest pain and back pain and became un-responsive when asked questions.

000 advised Albert not to give fluids - water.

Jason was coughing.

Ambulance in attendance 8.11p.m. - 8.22p.m. Meeting suspended.

Jason taken away in Ambulance.

Police contacted Albert Budworth regarding the situation. Albert advised that an Ambulance had been called. Police advised Albert that Jason Dodge is known to Police.

The Police stated that should there be any more problems please advise.

Meeting on hold 8.09p.m. until 8.23p.m. with two motions on the table,

Meeting resumed 8.23.p.m.

Val Sharpe rescinded his Motion.

The President asked Rod Roberts to re-state the Motion: That Jason Dodge be removed from Q.H.M.C. positions he holds in the Council, provided that the Constitution is followed and evidence provided Seconded: Ernie Taylor. All in favour: nil against. Carried.

Carle then advised the Meeting that as Jason is not present Jason has the Right to Appeal as per the Constitution.

20.3 A Member may be removed from office at a general meeting of the association if a majority of the members present and eligible to vote at the meeting, vote in favour of removing the Member.

20.4 Before a vote of members is taken about removing the member from office, the member must be given a full and fair opportunity to show cause why he or she should not be removed from office.

Jason Dodge has the right to appeal within three months in a letter not a text.

Trevor Beutel stated in a proper assembly for a fairest hearing

The President stated the next General Meeting Thursday 23 rd July 2020.

All present in agreeance. Nil against.

The President stated that as this is a General Meeting night. The President advised as Jason Dodge has been removed from the Treasurer's position a Casual vacancy position may be filled as per the

Constitution.

21.1 If a casual vacancy happens of the management committee, the continuing members of the Committee may appoint another member of the association to fill the vacancy until the next annual general meeting. (24th September 2020)

Carle Gregory nominated Cheryl Nott for the Treasurer's position.

Seconded: Albert Budworth,

All in favour. Nil against.

Carried.

The President stated the Secretary has already been working on the Treasurer's book-work.

Webmaster will be discussed at the next Management Committee Meeting Monday 1 June 2020. Two people have indicated interest in this position.

Membership Secretary will be combined with Treasurer's duties until the A.G.M.

Business arising from the Minutes:

Cheryl advised of Correspondence received form 21 May – 28 May, listed at end of Minutes.

That the Inwards correspondence be received and the Outwards correspondence be endorsed.

Moved: Cheryl Nott. Seconded: Dough Murphy. All in favour. Nil against

Treasurer's Report:

Presented by Cheryl Nott. Carle Gregory's signature added to four Club accounts on 30th April. Bank Teller advised that Treasurer (Jason Dodge) is uncontactable. Bank Teller advised Carle and Cheryl to remove Jason Dodge as a signatory with procedure to follow.

30th April Management Committee Meeting held, Minutes supplied to Bank on 1 May 2020. Jason Dodge's signature removed and electronic banking removed,
